# INDEPENDENT AUDITOR'S REPORT

## To the Members of SHREENATH INVESTMENT COMPANY LIMITED

#### Opinion

We have audited the accompanying standalone quarterly financial results of Shreenath Investment Company Limited (the company) for the quarter ended 31st March 2024 and the year to date results for the period from April 01, 2023 to 31st March 2024 attached herewith (the Statement), being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (Listing Regulations).

In our opinion and to the best of our information and according to the explanations given to us these standalone financial results:

#### **Basis for Opinion**
